MEDIA CORRESPONDENCE

Councillor Dave Hanhams expressed concern over voting procedures and stated that he feels that when there is "nay" vote, he would like to see Councillors state why they are voting nay. Councillor Hanhams stated that if you don't understand what you are voting for, that's one thing, but if you do and you are voting nay, you should state why you vote nay. Councillor Hanhams also expressed concern with the article that just appeared in the Guysborough Journal stating that no where in the article did it say what actually took place during budget deliberations. Councillor Hanhams stated that Mr. Alec Bruce did not get all the information or the entire storey noting that there are several contradictions in the article. Councillor Hanhams stated that Mr. Bruce wished to call him tomorrow, he would provide a statement to set the record straight. Councillor Hanhams noted that he wanted to include \$200,000 in the budget to address some of the requests from these organizations; however when asked who would be in favour of this addition, it was tied with four in favour and four against putting this in the budget.

Councillor Fin Armsworthy stated that he stands by his decisions.

Warden Paul Long stated that Council must now move forward in a positive way and working together.

Councillor Mary Desmond stated that although it took a few days with the working group to prepare the budget, it was a great democratic process. Councillor Desmond stated that according to Roberts Rules of Order, you cannot ask why someone voted they way they. Councillor Desmond stated that the Budget is over and that they have to move on noting that unfortunately, some things were outside of policy, but Council followed policy.

Warden Paul Long stated that going forward, it is very important Council understands and completes the Code of Conduct training. Warden Long noted that he understands both sides and collectively we have to do a better job.
